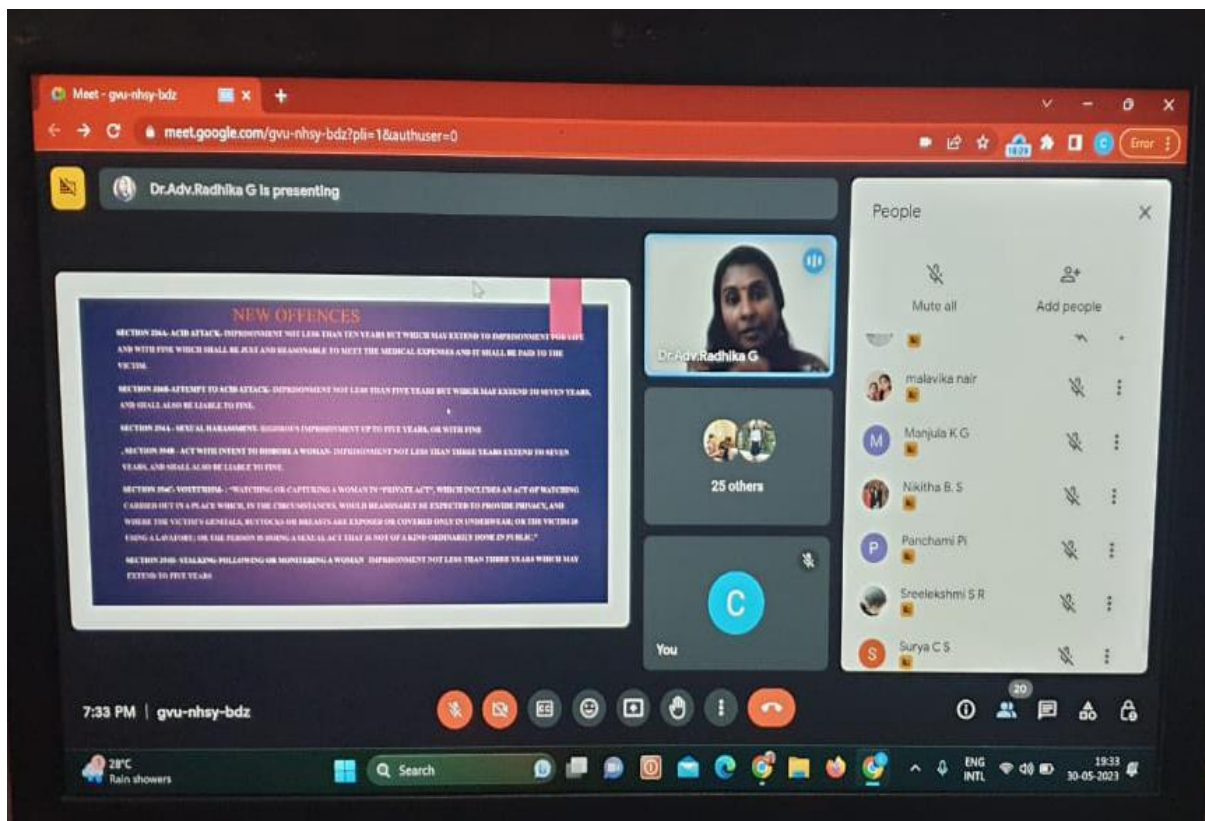
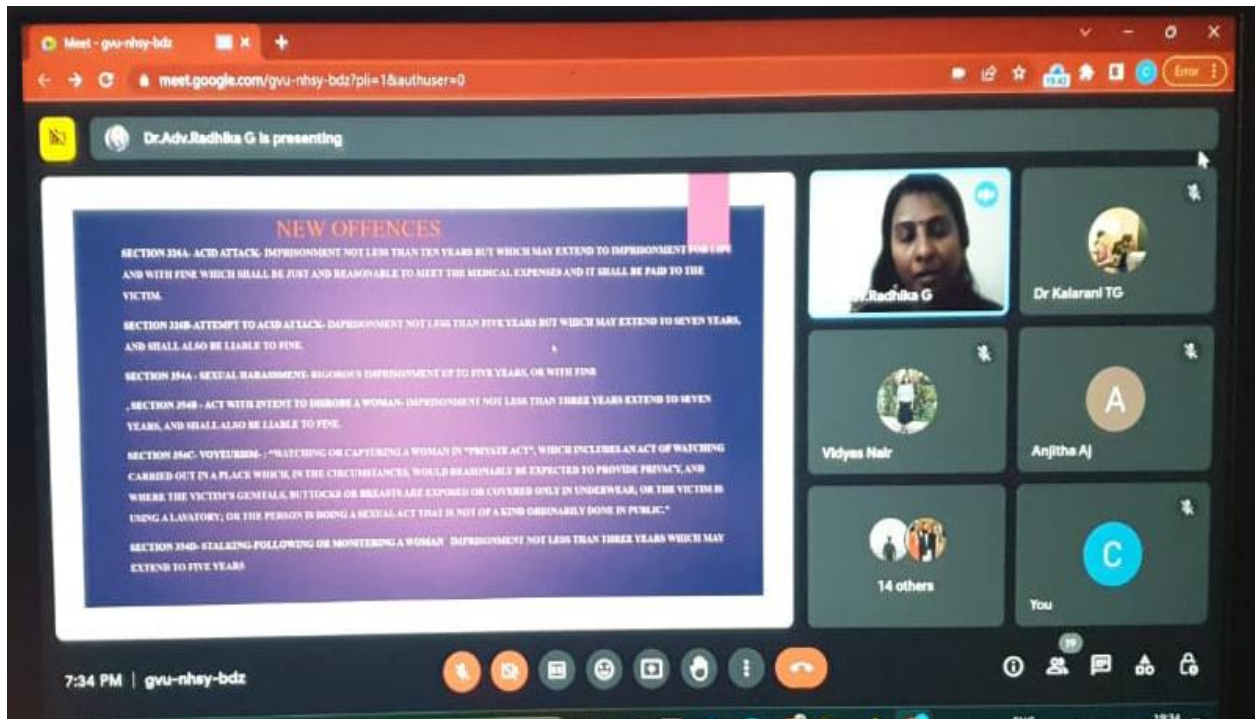
#### **d. Case Studies and Real-life Examples:**
